Jacob Abadi is an Adjunct Professor of History at Pratt Institute. He is the author of *Britain's Withdrawal from the Middle East, 1947-1971 - The Economic and Strategic Imperatives*. His forthcoming book *The Israeli Leadership - From Utopia to Crisis* will be published by Greenwood Press.
