

## CONTRIBUTORS

**M.E. Ahrari** is a professor in the Department of Warfare Studies at the U.S. Air War College. He is a specialist in US and Middle Eastern security matters, particularly in the Persian Gulf region.

**Peter Bardehle** is currently working as a research fellow in the Institute of International Politics and International Law at the University of the German Federal Armed Forces in Munich. A German fellowship grant enabled him to conduct the research for this article at the UN Secretariat in New York between May and December 1988.

**G. Davidson (Tim) Smith** is the counter-terrorism strategic analyst with the Ministry of the Solicitor General Canada. He is author of *Combatting Terrorism* (1990), and a contributor to *Democratic Responses to International Terrorism* (1991).

**John R. Ferris** is Associate Professor of History at the University of Calgary. He has written many articles on the history of British intelligence, diplomacy, strategy and military policy during the nineteenth and twentieth centuries. **Peter Gill** is Senior Lecturer in Politics and Criminal Justice at Liverpool Polytechnic, UK. He is co-author of *Introduction to Politics* and has published several articles on the oversight of Canadian security intelligence. **Bob de Graaff** is a staff member of the Institute of Netherlands History, and the Department of Japanese Studies at Erasmus University, Rotterdam. He is President of the Netherlands Intelligence Studies Association (NISA). **Joseph M. Scolnick, Jr.** is Professor of Political Science at Clinch Valley College of the University of Virginia. In 1988-89 he was a visiting professor at the U.S. Air War College. He has published and presented scholarly papers in his field of expertise, which is the relationship between foreign conflict and domestic policies.

**Geoffrey S. Smith** is Professor of History, and Physical and Health Education at Queen's University.
