Christon I. Archer is Professor of History at the University of Calgary. He has written extensively on the army of New Spain, the Mexican War of Independence and on Spanish naval activities in the Pacific. His works include *The Army in Bourbon Mexico*. He is currently working on insurgency and counterinsurgency in Mexico during the struggle of independence.

Ronald D. Crelinsten is a professor of criminology at the University of Ottawa. He has written extensively on the relationship between the media and terrorism. He is presently a research associate at the Center for the Study of Social Conflicts at Leiden University.

Cecil B. Currey is a professor of military history at the University of South Florida in Tampa. Among his many works are *Self-Destruction: The Disintegration and Decay of the United States Army During the Vietnam Era* (1981), and *Edward Lansdale: The Unquiet American* (1989).

John R. Ferris is Associate Professor of History at the University of Calgary. He has written many articles on the history of British intelligence, diplomacy, strategy and military policy during the nineteenth and twentieth centuries. His most recent book is *Men, Money and Diplomacy: the Evolution of British Strategic Policy, 1919-1926*.
