An edited collection entitled *Old English Literature and the Old Testament* is in press, and he is currently working on an edition of Alcuin's *Quaestiones in Genesim* and on a book on *Beowulf* and folktale.

R. D. Fulk is Class of 1964 Chancellor's Professor of English, Indiana University, and Adjunct Professor of Germanic Studies. Recent publications include (with †Richard M. Hogg) *A Grammar of Old English*, vol. 2, *Morphology* (2011); *The Beowulf Manuscript: Complete Texts and The Fight at Finnsburg* (2010); and *Klaeber's Beowulf and The Fight at Finnsburg* (2008). Soon to appear are (with Stefan Jurasinski) *The Old English Canons of Theodore* and *An Introduction to Middle English: Grammar, Texts.*

Christopher A. Jones is Professor of English at Ohio State University. He has published on various topics in Old English language and literature, monastic and liturgical history, and medieval Latin.

She has been working at the Oxford English Dictionary since 2004 and is currently Senior Assistant Editor, Etymology.

Michiko Ogura is Professor of English at Chiba University, Japan. She teaches Old and Middle English, the history of English, and English linguistics. Her special field is Old and Middle English syntax and word studies.
