ARTS AND SCIENCE

Courses complete in four years and leading to the B.A. or the B.Sc. in Arts Degree. Students may qualify for entrance to Medical or Dental Schools through selected courses.

EDUCATION

Degree of B.Ed. granted students with B.A. or B.Sc. degree on completion of one additional year. Courses approved by Minister of Education for Interim License of the High School Class.

ENGINEERING

Degree of B.Sc. in Civil, Electrical or Mechanical Engineering on completion of five years' work. Certificate in Chemical or Mining Engineering on Completion of three years' work, accredited by Nova Scotia Technical College towards Degree.

FORESTRY

Degree of B.Sc. on completion of five years' work. Practical instruction stressed on two forest areas comprising 7,000 acres controlled by the University.

LAW

Beginning September 1951 the complete first year of Law will be available at Fredericton. Two courses will be given one year and three the next, to a combined Junior-Senior Class. These courses will rate as credits for the B.A. degree.

GRADUATE SCHOOL

Courses are available in Forestry and in several of the Arts and Science Departments for the Master's Degree.

SUMMER SCHOOL

Courses in Arts and Science for the B.A. degree. Graduate courses also for the Master's Degree. The Observatory Art Centre offers courses in Painting and Sketching. University Residences provide pleasant living accommodation.
